# Change/deletion of personal data

# **Use of Personal Data**

We potentially use your Personal Data for various purposes:

- Your Personal Information is used to maintain contact with you about the products and/or services purchased from us or to be purchased in the future.
- Your Personal Data can be used to send you informative digital messages about new products and/or services. With these messages we keep you informed about expansion and improvement of our services and products. Each informative digital message contains a link that allows you to unsubscribe from the mailing list.
- > Your Personal Data can be used for invitations for business meetings.
- > Your Personal Data can be used to optimise our products and services.
- > Your Personal Data will be used to comply with legal obligations.

# We only process Personal Data based on one the elaborated legal grounds.

- We process your Personal Data on the basis of your consent.
- We will process your Personal Data on the basis of an agreement or at your request prior to the conclusion of a final agreement. Such an agreement is entered into when you make use of our products and/or services.
- We process your Personal Data on the basis of a legal obligation.
- We process your Personal Data on the basis of a legitimate interest.

# **Processing parties**

It is possible that we make use of service providers (processors) who process Personal Data on our behalf for the provision of our services.
